Introduction

Collection title: Durham Cathedral Archive: Eleemosinaria

Reference code: GB-0033-DCD-Eleomos

Dates of creation: [medieval]

Extent: 6 original boxes

Repository: Durham University Library, Archives and Special Collections

Creator: documents concerning the properties, etc., that constituted the estate of the almoner; some now missing.

Language of material: Latin

Accession details

Placed in the University's care by the Dean and Chapter of Durham in 1948.

Arrangement

The numbering system reflects the medieval organisation of the documents in boxes with multiple compartments: the first number is the compartment, the second the box, and the final one the number in the sequence (thus 1.2.Eleomos.5 is the fifth document in the first compartment of the second box). The numbers were assigned in the Repertorium Magnum.

Stock checks

Stock checked by William Greenwell, late 19th century (in Misc.Ch.7309), February 1965 and (outer envelopes only) September 2023.

Only discrepancies are as follows:

- 5.1.Eleomos.18 is not noted as in duplicate by Greenwell, though 18a and 18b were recorded 1965 and 2023
 - 2.2.Eleomos.9 is not noted as missing by Greenwell, though it is recorded as missing in 1965 and 2023
 - 3.2.Eleomos.14-22 are not included in Greenwell's list (all but one are now part of Misc.Ch., with 3.2.Eleomos.22 untraced)
 - 4.2.Eleomos items that are now part of Misc.Ch. are either omitted from Greenwell's list (1c, 6", 6"bis, [15], [16], [17], 18-20), or noted as "not here June 8 1892" (7-12, 14)
 - 6.2.Eleomos.4-5 were missing in 1965, but found in 1979 and present 2023
 - 3.4.Eleomos.6 is recorded by Greenwell as in triplicate, but in fact 4 copies survive and were noted in 1965
 - 5.4.Eleomos.3 is not explicitly noted as missing by Greenwell but his entry implies it may have been (see list) - it was missing 1965 and 2023
- Some items are noted as 'wanting' by Greenwell, though they have now been identified within Misc.Ch., as noted within the catalogue entries

Previous finding aids

Alm.Sm.Cart. p.39-66 is an inventory, with index of places (p.39), to the charters of the office of the almoner of Durham, drawn up by William of Appleby almoner in 1399; considerably annotated, amended and enlarged, mostly in the hands of John Fishburn and Thomas Swalwell.

Misc.Ch.7309 is a list compiled by William Greenwell, apparently from Alm.Sm.Cart. p.36-66, supplemented by original documents not included in that inventory, as identified by their endorsements.

Sale and quitclaim by William son of Adam of Bradbury to Robert of the Monastery of all his land in the vill of Aycliffe (*Acley*) for 13 marks which Robert gave him in his great necessity, to be held of the prior and convent of Durham, rendering annually to them 2s 6d.

Quitclaim by John son of John of Ketton to God, St Cuthbert and the almoner of Durham of his right in all the land that Laurence Janitor his uncle formerly held of him in the vill of Aycliffe (*Acley*), saving 14d annually in equal portions at Pentecost and St Martin, interchangeably sealed by the said John and Dom Nicholas [?of Hexham] almoner of Durham.

Lease by Dom Thomas Swalwell almoner, Prof Sac Theo, of the cathedral church of Durham, with the assent and will of his venerable father Hugh [Whitehead] prior and the convent of Durham, to Roland Simpson of Aycliffe, of a messuage with a barn, (*orrio*), stable and croft, and a cottage and barn next to the River Skerne, and a cottage on the north part there, with 67 acres of land and meadow, with a rod of land etc which the almoner has in the vill and territory of Aycliffe (*Acley*), from St Martin last for 15 years, rendering annually to the almoner at the almoner's exchequer in Durham 33s 4d in 2 equal portions at Pentecost and St Martin, with the first payment o tbe at Pentecost next, with right of reentry and distraint to the almoner if the rent is behind by 14 days, with Roland to maintain the buildings and if necessary build anew at his own expense, with Richard Newsam and Thomas Doby of Aycliffe to be his pledges, obligated in 5 marks thereby.
