Preface

Creation of catalogue

The first section, Books, combines two volumes of Halmote Court lists, Halmote Court Books, prepared Dr C.I.A. Ritchie and revised N. Million, May 1956 and Miscellaneous Books, N. Million, July 1957, revised in 1984. Both have been extensively annotated since, and these comments have been worked into the text (although sometimes the marginalia were less than comprehensible or legible). There are many expansions on odd sheets of typescript etc, which have been incorporated when possible. Both were re-keyed ES 1996, and combined in SGML by RIH January 1997.

Original Surrenders were listed in four volumes: 1. Auckland and Chester Divisions; Typescript list N Million September 1961. 2. Darlington, Easington and Houghton Divisions; Typescript list N Million November 1961. 3. Lanchester, Stockton and Wolsingham Divisions; Typescript list N Million February 1962. 4. Bedlington, Bishopwearmouth Rectory, Evenwood, Middleham and Whickham manors; Typescript list N Million March 1962. All rekeyed ES July 1997. SGML markup (using awk) RIH August 1997.
