Preface

Creation of catalogue

Typescript/hand written cards by M. G. Snape and A. J. Piper c.1965-1980, wordprocessed by SF 1997. SGML by R. I. Higgins April 1997, using amended did element to allow components in the middle of parent component did's, and TEI element extref to refer to external ids.

Remaining cross refs: Pont; Arch. Dun; Arch. Northumb; Spec; Ebor; Misc Ch; Locelli; Cart II; Cart III; Reg. II; Reg. IV; Chamberlain's Cart.; MS B.IV.26. The original boxes have been treated as hierarchical units: this is partly for convenience, to break up the lists into smaller pieces for downloading, but also because the evidence often suggests that the divisions within boxes were significant (they do not merely fill one section and proceed to the next, as is evident from the varying quantities and date spans of documents).

Introduction

Collection title: Durham Cathedral Archive: Papalia

Repository: Durham University Library, Archives and Special Collections

Creator: documents issued by the pope relating to the monastic community, with some associated material; some now missing.

Language of material: Latin.

Accession details

Placed in the University's care by the Dean and Chapter of Durham in 1948.

Arrangement

The numbering system reflects the medieval organisation of the documents in boxes with four compartments: the first number is the compartment, the second the box, and the final one the number in the sequence (thus 3.2.Pap.5 is the fifth document in the third compartment of the second box). The numbers were assigned and amended in the Repertorium Magnum, and some duplications and confusion may have crept in, which is noted below.

Stock checked by William Greenwell (late 19th century, marked by pencil ticks within Repertorium Magnum), July 1960 and (outer envelopes only) April 2023. Only discrepancy is as follows:

4.1.Pap.31 not ticked by Greenwell, but present in 1960 and 2023
