This cartulary comprises three main sections: the oldest, ii ff. 1-142v and 151-152v, is in the same style as Cart.I and Cart.II, which were compiled in the second decade of the fifteenth century, but, save for ff.92v-104v, lacks rubrication; i ff. 1-48 is similar to Cart.IV, s. xv/xvi; and ii ff. 153-354v includes a document dated 1504 (ff.249v-251v).

{Replies, by the prior of Durham, to complaints of the mayor and burgesses of Newcastleupon-Tyne about their rights in the Tyne and principally at South Shields, by reference to grants in 883 to St Cuthbert of all the land between Wear and Tyne and by Kings William I, William II, Henry I, Stephen, Henry II, Richard I and, in [1204], John [3.1.Reg.16], so predating John's grant to the mayor and community of Newcastle in 1212-13, with mention of Wallsend and Willington; answers to eight articles, with mention of the agreement between John Fossor prior of Durham and Peter Graper mayor and other burgesses of Newcastle over sales of fish at South Shields [Reg.II ff.143v-144r: 1353]; instructions to be shown to the bishop's and the prior's council, quoting a charter by King Henry I [2.1.Reg.5] produced in court in London by the late Bishop Langley [d. 1437] on the day that the tower and part of the Tyne bridge were recovered [1416: HDST p. ccvii, and cf. Storey p. 54 n. 6], together with the record of an inquest in the time of King Henry I and Ranulf [Flambard] bishop [of Durham, d. 1128] before Walter Espec and Eustace fitz John [as Reg.II ff. 178v-179r and Misc. Ch. 6588: RPD III,39-41, and see SS 179 pp. 62-63], with mention of an inquest in the time of King Henry II before Roger [of Pont L'Evêque] archbishop of York, Robert [de Chesney, d. 1166] bishop of Lincoln, Hugh [of Le Puiset] bishop of Durham, and Richard de Lucy; referring to the case over the seizure of the liberty of Antony [Bek] bishop of Durham by H[ugh] of Cressingham and his fellow itinerant justices resolved in parliament in London [in October 1293], as recorded in the book of parliamentary petitions for 21 Edward [I] cap. xxv kept at the royal exchequer and exemplified 9 March 10 Henry V [impossible: dead for seven months]; quoting from charters by King Henry II for Bishop Hugh [of Le Puiset, HDST p. lii] and for the monks of Durham [3.1.Reg.4, HDST p. xlix]; quoting the record of an inquest by Simon Esh sheriff of Durham, Monday after Margaret v blank pont. Richard [Kellawe or Bury; if the latter must be 25 July 1334], with mention of the Gateshead market each Tuesday and Friday up to the middle of the [Tyne] bridge and the fair on Peter ad vincula [1 August], the fisheries of the bishop and the prior in Pipewelgate and Shields, the shipment of the prior's wool from Holy Island to Shields, and the burial at Gateshead of William de Aillosam after falling from the bridge into the river; on the basis of which Bishop Richard obtained a writ from King Edward [II or III] (recited) dated York 20 August Reg. 8 [1314 or 1334]; citation of a rental dated 1235, showing 24 tenants at Shields, the rental being called Melsonbybook and of comparable authority for the priory as Boldon Book for the bishopric; reference to a charter by William [of St Calais] bishop of Durham [1.1.Pont.1a, SS 179 pp. 53-58]; citation of Melsonbybook and other rentals regarding payments by brewers at Shields; reference to a charter by King William I. Probably a copy of the replies drawn up at Prior Wessington's instigation, see *HDST* p. cclxxi; cf. Loc.II:3 and 9.]

{Mandate, by Richard [II] king of England, to sheriffs, mayors, bailiffs, ministers and others, to allow the prior and monks of Durham their freedom from royal dues and their court, following his confirmation of the liberties granted to them by his ancestors as kings of England [cf. 3.4.Reg.6]

Quoting 4.1. Archiep. 1, and mentioning Tukyll son of Quebild [Turkil son of Quenilda: Liber Vitae ff.50v-51, EYC II,270] holding two carucates in Lazenby; quoting 1.1.Archiep.1 or 2; mentioning confirmations by Thurstan, Roger [of Pont L'Evêque], Geoffrey and Walter [Giffard], archbishops of York, quoting 2.1. Archiep. 2. dated 18 years before the establishment in 1291 of Lazenby chantry by John de Lythegreynes, with the consent of Antony [Bek] bishop of Durham, and quoting the confirmation by the prior and chapter of Durham [see Reg.II f.322r-v]; mentioning members of the household of the late Joan [Beaufort] countess of Westmorland [d. 1440]; quoting 4.1. Archiep. 2c; referring to the visitation by Archbishop Henry Bowet and the sentence by his chancellor and commissary Mr Richard Pittes [3.2.Archiep.1]; quoting the agreement between Archbishop William [Melton] and Louis [Beaumont] bishop of Durham [as in 1.2.Archiep.2]; citing examples of the exercise of the jurisdiction in Lazenby and the bishop's manors of Howden and [North] Allerton, mentioning the case of adultery between Roger Carter of Lazenby and Alice of Birkby in 1327, Alexander and William of Wath chaplains of Lazenby in 1334. the will of William Wright of Lazenby in 1372, Thomas of Hunton in 1387 before Robert of Blacklaw and Roger of Mainsforth monks of Durham and commissaries of the prior, Nicholas Coiser chaplain in the bishop's manor in 1388 before Robert of Blacklaw and other commissaries of the prior and in 1405 before Thomas Rome and William Barry [monks of Durham and] commissaries of the prior, and Thomas Lazenby in 1492 [for 1392] before Robert Ripon and Thomas Lythe [monks of Durham and] commissaries of the prior

{Evidences for the pensions to be paid to the prior of D[urham] from his churches in the diocese of York [and his jurisdiction in them].} under seven heads:

First quoting from two charters by William [of St Calais] bishop of Durham [1.1.Pont.2, SS 179 pp. 15-20; and 1.1.Pont.3, SS 179 pp. 26-29), and charters by Thomas I, Thurstan and Roger [of Pont L'Evêque], archbishops of York (1.1.Archiep.1, SS 58 pp. lxxvi-ix; 1.1.Archiep.7, EYC II,274-75; 1.1.Archiep.4, Scammell pp. 265-66), and by referring to confirmations by Popes Lucius III and, with a quotation, Honorius III (Were 1.1.Pap.29, PU no. 223, and 2.1.Pap.11, see Cart.Vet. ff.12v-13r and 37r).

Second quoting [again] from a charter by Thomas I archbishop of York (1.1.Archiep.1, SS 58 pp. lxxvi-ix).

Third by quoting grants of the churches of Holtby, Brantingham with the chapel of Blacktoft, and Skipwith (as Reg.l.i. ff.119r, 120r-v and 120r).

Fourth by quoting from a charter by Walter [Gray] archbishop of York (2.1.Archiep.1, SS 56 pp. 153-54).

Fifth by quoting receipts by archdeacons of the East Riding for payments by the prior and chapter of Durham of an annual pension of 4 marks for their jurisdiction in Howden and Howdenshire in 1279, 1357, 1372 and 1434.

Sixth by mentioning to charters by Thurstan, Roger [of Pont L'Evêque] and Geoffrey [Plantagenet], by quoting from a charter by Walter [Giffard] archbishop of York (2.1.Archiep.2) and from an agreement between William [Melton] archbishop of York and the prior and chapter of Durham (4.1.Archiep.2), and by mentioning the sentence by Mr Richard Pittes (3.2.Archiep.1) confirmed by Pope John XXIII (Was 2.2.Pap.8, see Cart.I ff.22r-27r).

Seventh by argument referring to *Extravagantes*?, [Henricus] Host[iensis] on *Extravagantes*, the Archdeacon [Guido de Baysio] on *Liber Sextus*, *Summa* of [Henricus] Host[iensis], etc.

Evidences for the right of the prior and convent of Durham to receive an annual pension of 10 marks from the church of Brantingham, apparently as f.i.15r-v below; and then referring to the payment of 4 marks a year by the prior and chapter to the archdeacon of the East Riding to indemnify him for their jurisdiction in the churches of Hemingbrough, Howden, Brantingham, Welton, Walkington and Skipwith; and to the holding of chapters and the probate of wills by the officials of the prior and chapter of Durham in the churches of Howden and Howdenshire, with the perquisites shown in the accounts of the bursar of Durham.

Letter, by Cardinal J[ohn Kempe] archbishop of York, to the prior of Durham, charging him not to allow his archidiaconal jurisdiction in Howdenshire to be occupied by any other person in Howdenshire, since some with cures there have wrongfully done so in their cures.

Evidences for the right of the prior and convent of Durham to receive an annual pension of 10 marks from the church of Brantingham, referring to the case between them and John Hansard over the advowson of Blacktoft church and reciting 1.3. Ebor. 30; stating that they granted the church of Brantingham with the chapel of Blacktoft to their clerks down to the Lateran Council, reciting grant to Mr Odo of Kilkenny (as Reg.l.i. f.120r-v), and referring to grants of the churches of Walkington for a pension of 100s., the church of [Kirby] Sigston for a pension of 10 marks and the vicarage of [North] Allerton for a pension of £20; stating that after the Lateran Council they presented to the church of Brantingham, reserving the pension of 10 marks; and citing the grant by Thomas I archbishop of York [1.1.Archiep.1 and 2: spurious] concerning their jurisdiction in their churches in Howdenshire and Allertonshire.

Richard Hoton clerk, aged 50 and more, stated as William Fynchess, but without mention of Mr Peter of Kelloe or the tithes of Worsall and Lazenby.
